## Cancellation Policies - Jim approved, Matt second

Once registered for a participating tournament (GNBL, LCT, State or Other), you are expected to fulfill those obligations. If you wish to cancel, it must be approved by the board with written justification and board presence to state your case where a decision will be voted by majority rule.

\*Note: Typical cancellation approvals for medical, injury, illness will be given strong consideration. Cancelling for an alternative schedule or different opportunity will not constitute valid justification.

## Non board sponsored scrimmages and events - Tabled until next meeting

There are times where a scrimmage or small team tourney may take place outside of board oversight. These scrimmage events are the responsibility of the head coach to manage any/all communications, injury readiness, gym readiness with school approval and site administrator/crowd control. Payment for referees are typically out of pocket, door fee or agreed upon split cost by all attending teams and divided up by parents/coaches unless brought forth to the board at least 30 days in advance for an approved amount that is voted and agreed to by the board.
